# Faculty Biographies

# Quintin Broussard, PharmD, BCPS, BCCCP, BCNSP

Dr. Quintin Broussard, who joined KGI in August 2018, completed a Bachelor of Science in Chemistry and a minor in Mathematics from McNeese State University in Lake Charles, LA. He received his Doctor of Pharmacy degree from the University of Houston College of Pharmacy. After graduating from the University of Houston, Dr. Broussard completed a PGY1 Pharmacy Practice Residency and a PGY2 Critical Care Pharmacy Residency at Baylor St. Luke's Medical Center in Houston, TX, within the Texas Medical Center. He is board certified by the Board of Pharmacy Specialties in Pharmacotherapy, Critical Care, and Nutrition Support.

Prior to joining KGI, Dr. Broussard was an Assistant Professor of Clinical Sciences at California Health Sciences University (CHSU), practicing in medical/surgical intensive care and nutrition support. During his two years at CHSU, he was honored as the Clinical Faculty Preceptor of the Year for IPPE 3, P3 Teacher of the Year, and as the Course Director for the P3 Course of the Year (PHR 746: Patient Care III).

Dr. Broussard is actively involved in multiple organizations. He currently serves as the Pacific Regional Director for Collegiate Affairs for Phi Delta Chi Pharmacy Fraternity and on the Self Assessment and Nutrition Science & Practice Conference Monitoring Committees for the American Society for Parenteral and Enteral Nutrition. In addition, Dr. Broussard is a member of the American Association of Colleges of Pharmacy, the Society of Critical Care Medicine, and Phi Lambda Sigma – Pharmacy Leadership Society.

Clinically, Dr. Broussard practices at San Antonio Regional Hospital in critical care and nutrition support. His practice interests include management of sepsis/septic shock, parenteral nutrition, and fluid/electrolyte disorders. Dr. Broussard's research interests include evaluation of parenteral nutrition prescribing patterns and outcomes, incorporation of nutrition support education into didactic Doctor of Pharmacy curricula, and development and assessment of objective structured clinical examinations and clinical skills.

# Christine Cadiz, PharmD, MA

Dr. Cadiz joined the KGI School of Pharmacy and Health Sciences in August 2015 from Palomar Medical Center in San Diego, CA, where she has been practicing as an inpatient transitions of care pharmacist. In this role, she works closely with members of the interdisciplinary health care team to optimize medication therapy and to provide education prior to discharge from the hospital. The main goals of the program are to empower patients and their families and to reduce hospital readmissions. Dr. Cadiz will continue her work with the inpatient transitions of care team at Palomar Medical Center. Additionally, she will be establishing outpatient transitions of care clinics in the ambulatory care setting and exploring opportunities to improve care transitions from skilled nursing facilities.

Dr. Cadiz is a Board Certified Pharmacotherapy Specialist. She has a teaching background and holds her Master of Arts in Teaching from the University of California, Irvine. She earned her PharmD degree from the University of California, San Diego, and completed a PGY1 pharmacy practice residency at the University of California, San Francisco.

# Minh Dang, RPh

Minh Dang, who joined KGI in February 2013, has a great deal of experience working with young professionals beginning their careers in pharmacy and in implementing educational programs for pharmacists. Prior to joining the KGI School of Pharmacy and Health Sciences' administrative team, she served as the manager of professional and college relations at CVS Caremark where she was instrumental in developing the company's college recruitment and relations programs. She also played a vital role in expanding the CVS Caremark Preceptor Program, including appointing more than 275 certified preceptors and establishing a Structured Summer Internship Program.



Previously, she was an assistant professor at UC San Diego Skaggs School of Pharmacy and Pharmaceutical Sciences and held several management positions at Albertsons/Sav-On, Inc. Ms. Dang is active on several advisory boards, including the community advisory boards of the Pharmacy Foundation of California and the San Diego Pharmacist Resource and Research Network. She holds a Bachelor of Science in pharmacy from the Massachusetts College of Pharmacy and Health Science. As the assistant dean for experiential education, Ms. Dang will be responsible for securing affiliation agreements for experiential education sites and conducting and supervising site visits.

# **Angela Davis, PharmD**

Prior to joining the KGI School of Pharmacy and Health Sciences in January 2016, Dr. Davis was a clinical pharmacist at the U.S. Air Force Academy Clinic, 10th Medical Group, Colorado Springs, Colorado. As a member of the staff, she was the coordinating preceptor for the Advanced Pharmacy Practice Experience (APPE) program.

In this capacity, Dr. Davis coordinated for the annual rotation of approximately 20 pharmacy students from four pharmacy schools for the ambulatory care, general medication, advanced community, and drug information rotations. Additionally, she managed the medication therapy management clinic, and the anticoagulation clinic. Before her assignment at the Air Force Academy, Dr. Davis worked in retail pharmacy as the manager of the Sam's Club Pharmacy in Colorado Springs, and as a pharmacist at Target Stores in Denver and other cities throughout Colorado. She earned the Doctor of Pharmacy degree from the University of North Carolina at Chapel Hill, Eshelman School of Pharmacy, and a B.S. in Business Administration from the University of North Carolina at Charlotte.

# Sally Huston, PhD

Dr. Huston, who joined KGI in January 2014, is a Professor of Social and Administrative Sciences in the Department of Clinical and Administrative Sciences. Her main research stream focuses on the psychosocial aspects of diabetes. A current research project is a case-control study that will assess the impact of a resilience intervention on adults with diabetes.

Dr. Huston is also interested in fostering pharmacist role expansion. In the past, she has called for role expansion through creation of a class of pharmacist prescribed medications. More recent work has qualitatively and quantitatively investigated the impact of interventions enhancing immunizations delivery in community pharmacies. Another approach she is taking to pharmacist role expansion is the psychosocial investigation of entrepreneurship among Doctor of Pharmacy students. She has one publication in this area to date, and is currently collecting additional data.

Dr. Huston has a long history of service with the American Association of Colleges of Pharmacy, and is currently serving as the secretary of the Social and Administrative Services Section and as the KGI School of Pharmacy and Health Sciences (SPHS) delegate to the organization. She is currently Chair of the Student Scholarships, Awards, Honors, and Ceremonies Committee at KGI SPHS, and a member of the Program Assessment Committee and the Student Conduct Committee.

Dr. Huston coordinates and teaches in three courses, and teaches additional lectures in other courses.

# Jeany Kim Jun, PharmD, APh, BCACP, MPH

Jeany Kim Jun, PharmD, APh, MPH, BCACP, who joined KGI in September 2015, was promoted to Chair of Clinical and Administrative Sciences and Associate Professor on February 10, 2020. Prior to that, she was an Associate Professor of Clinical and Administrative Sciences in the School of Pharmacy and Health Sciences (SPHS), and is an Advanced Practice Pharmacist in California. Before joining KGI,



she was an Assistant Professor in the Department of Pharmacy Practice at Loma Linda University School of Pharmacy and at Western University of Health Sciences College of Pharmacy.

She is a Board-Certified Ambulatory Care Pharmacist. She received her PharmD from the University of California, San Francisco and completed a residency in Primary Care Pharmacy Practice at the University of Southern California. She holds a Master of Public Health in Health Administration and International Heath from Loma Linda University School of Public Health and a Bachelor of Arts in Russian Studies from UCLA.

Dr. Jun teaches the Endocrine and Urology therapeutics courses as well as the Pharmacists' Patient Care Process elective to medication therapy outcomes certificate students. Dr. Jun's clinical practice site was at Emanate Health (formerly Citrus Valley Health Partners), Population Health – Diabetes & Specialty Care Clinic. She helped to develop and establish the pharmacist-managed diabetes clinic and worked under a collaborative practice agreement, managing English- and Spanish-speaking patients with diabetes and other conditions. She precepted fourth-year pharmacy students and pharmacy residents at the clinic. Her research interests include diabetes outcomes in Hispanic patients. Dr. Jun received the Excellence in Teaching Award from different classes of students at KGI SPHS in 2019, 2020, and 2021. She also received the Teacher of the Year award from Loma Linda University in 2012, 2013, and 2015 and also received the Preceptor of the Year Award from Western University in 2010 and from Loma Linda University in 2015.

# Stephanie Kourtakis, PharmD, BCACP

Dr. Stephanie Kourtakis joined Keck Graduate Institute (KGI) School of Pharmacy and Health Sciences in August 2018 as an Assistant Professor of Clinical Sciences. She currently serves as course coordinator and lead instructor in the first-year patient assessment and self-care courses and interprofessional education (IPE) coordinator.

Dr. Kourtakis earned her Bachelor of Science degree in Health Sciences from Oakland University in Rochester, MI, and Doctor of Pharmacy degree from the University of Michigan College of Pharmacy in Ann Arbor, MI. She completed a PGY1 Community Pharmacy Residency at Mercer University College of Pharmacy and Kroger Pharmacy in Atlanta, GA, and a PGY2 Ambulatory Care Pharmacy Residency at Nova Southeastern University College of Pharmacy in Fort Lauderdale, FL. Dr. Kourtakis is a Board-Certified Ambulatory Care Pharmacist.

Dr. Kourtakis currently practices as an ambulatory care pharmacist at Riverside University Health System Medical Center (RUHS-MC). At RUHS, she serves as a preceptor for fourth-year student pharmacists in the family medicine practice setting with emphasis in diabetes management, medication therapy management, and geriatric care.

Dr. Kourtakis is a member of the American Association of Colleges of Pharmacy, the American Pharmacists Association, Phi Delta Chi Pharmacy Fraternity, and Phi Lambda Sigma – Pharmacy Leadership Society. She serves as a faculty advisor for the KGI chapter of the American Pharmacists Association Academy of Student Pharmacists (APhA-ASP) and the KGI California Pharmacy Student Leadership (CAPSLEAD) team.

Her research interests include the science of teaching and learning and diabetes outcomes.

# Daniel Kudo, PharmD, FCSHP, APh

who joined KGI in March 2017, is a clinical pharmacist with more than 20 years of hospital and health plan management experience. For the last 16 years, Kudo was a Medical Science Liaison (MSL) for a major pharmaceutical company.

Kudo received his PharmD degree from the University of Southern California School of Pharmacy and completed a clinical pharmacy residency at Los Angeles County – USC Medical Center.

In addition to his hospital managerial functions, he helped to develop the clinical pharmacist's role in the areas of adult and neonatal critical care, and the role of the pharmacists in the transitional care unit (TCU) at a 450-bed hospital in the San Gabriel Valley. As Director of Pharmacy of a regional health plan, Kudo managed the pharmacy benefit, and helped to develop quality outcome measures. As an MSL, he developed relationships with and gained insight from regional, national, and internationally recognized



thought leaders in the areas of asthma/allergy, endocrinology, and cardiology. In addition, he identified research sites and coordinated both company-sponsored and independent sponsored research studies.

# Yousef Lafi, PharmD, BCIDP, AAHIVP

Dr. Lafi completed a Bachelor of Science in Pharmaceutical Sciences and a minor in Chemistry from North Carolina Central University in Durham, NC. He received his Doctor of Pharmacy degree from Campbell University College of Pharmacy and Health Sciences in Buies Creek, NC. After graduation, Dr. Lafi worked as a consultant pharmacist in the medical communications department with Pharmaceutical Product Development (PPD Inc.) in Morrisville, NC, and part-time as a clinical pharmacist at the Outpatient Pharmacy at Duke University Children's Hospital in Durham, NC.

Dr. Lafi pursued residency training and completed a PGY1 Pharmacy Practice Residency at Virginia Hospital Center in Arlington, VA, and a PGY2 Infectious Diseases Pharmacy Residency at BronxCare Health System in Bronx, NY. He is board certified by the Board of Pharmacy Specialties in Infectious Diseases and is a certified HIV Pharmacist by the American Academy of HIV Medicine.

Dr. Lafi was an Assistant Professor of Clinical Sciences at California Health Sciences University, where he served as co-director of the Patient Care IV (Infectious Diseases/Oncology) course. During his tenure at CHSU, he was honored as the P3 teacher of the year in 2019. Clinically, Dr. Lafi practices at San Antonio Regional Hospital as an Infectious Diseases Pharmacist Specialist. His current research interests include antimicrobial stewardship, HIV, and resistance patterns of gram-negative bacteria.

# Mylene Manalo, PharmD, BCPS

Dr. Manalo joined the KGI School of Pharmacy and Health Sciences in September 2016 from Desert Oasis Healthcare (DOHC) in Palm Springs, California. At DOHC, she served as the Lead Population Health Pharmacist, working with members of interdisciplinary health care teams to support and develop patient health education programs and implement the ambulatory care clinic for management of COPD patients. The COPD clinic is one of the newest editions to DOHC's collaborative practice programs, including anticoagulation, diabetes, hypertension, coronary artery disease, and hepatitis C. DOHC Pharmacy Services also include a refill clinic, medication review and reconciliation program, and antimicrobial stewardship during transitions of care.

Dr. Manalo received a B.S. in Clinical Laboratory Science from Loma Linda University and worked primarily in Microbiology and Immunology until completing pharmacy school. She earned her PharmD from Loma Linda University in 2011 and completed a PGY1 pharmacy practice residency with an emphasis in pediatrics at Long Beach Memorial and Miller Children's Hospital in Long Beach, CA. During residency, Dr. Manalo was trained under acute care pharmacist-managed medication protocols for both adult and pediatric patients. Dr. Manalo made the transition from acute care practice to the ambulatory care setting when offered a position to provide Clinical Pharmacy Services within the Heritage Provider Network in 2013.

Dr. Manalo currently is a Board Certified Pharmacotherapy Specialist and wishes to pursue further certifications, with specific interests in diabetes, tobacco cessation, and geriatrics. She is a member of various pharmacist organizations including ACCP, ASHP, CSHP, and CPhA. She is very delighted to be working with pharmacy students and residents.

# Gail Orum, PharmD, BCGP

Dr. Orum, who joined KGI January 2015, has spent the largest portion of her career focusing on advancing health professions education. She currently serves as SPHS Associate Dean of Academic Affairs.

Before joining KGI, she spent seven years as the Dean of the College of Science and Health at Charles R. Drew University of Medicine and Science, where she was responsible for the development, implementation, and accreditation processes of such programs as Nursing, Pharmacy Technology, Physician Assistant, Public Health, and Radiologic Technology.



In her capacity as a faculty member, Dr. Orum developed and taught pharmacology curriculum to nursing, physician assistant, and nuclear medicine technology students. She also held an adjunct faculty appointment at the USC Keck School of Medicine, Department of Family Medicine, Physician Assistant Program. Her research involves the impact of medication non-adherence on health outcomes for medically disadvantaged populations. Dr. Orum has served as the principal investigator or coinvestigator on several grants, some of which were funded by the US Department of Education, California Office of Statewide Health Planning and Development (OSHPD), Centers for Medicare and Medicaid Services (CMS), Robert Wood Johnson Foundation (RWJF), and the National Institutes of Health (NIH). She holds membership in many organizations, and has served on numerous boards and committees including the National Library of Medicine Environmental Health Information Partnership, Association of Schools of Allied Health Professions, and the Health Careers Connection Advisory Committee.

In addition to her academic career, Dr. Orum has had the opportunity to practice in numerous pharmacy settings including investigational drug services, chain pharmacy, long-term care pharmacy, home infusion services and HMO. She earned the Doctor of Pharmacy degree from the University of Southern California-School of Pharmacy, and is a board certified geriatric pharmacist.

# Talia Puzantian, PharmD, BCPP

Dr. Puzantian, who joined KGI in January 2016, is Professor of Clinical Sciences at Keck Graduate Institute School of Pharmacy and Health Sciences. Prior to joining KGI, she was a clinical psychopharmacology consultant in private practice. Previously, Dr. Puzantian was a psychiatric clinical pharmacy specialist and an Associate Clinical Professor at San Francisco General Hospital and at the University of California, San Francisco for nine years. She received her BS in Psychobiology from UCLA and her PharmD from the UCSF School of Pharmacy. She completed a psychiatric pharmacy practice residency at LA County/USC where she was honored as Pharmacy Resident of the Year. Over the course of her teaching career, Dr. Puzantian has been recognized with several teaching awards.

Dr. Puzantian was in the first group of specialists to become a Board-Certified Psychiatric Pharmacist and has, in the past, served as the Chair of the Specialty Council on Psychiatric Pharmacy for the Board of Pharmaceutical Specialties. She is an active member of the College of Psychiatric and Neurologic Pharmacists (CPNP) and advisor to the KGI student chapter of CPNP. Dr. Puzantian's scholarly interests focus on pharmacists' roles in mitigating the opioid crisis, suicide prevention and mental wellness in university students, and equipping pharmacists with Mental Health First Aid training. She currently practices as a psychiatric pharmacy specialist at Adventist Health Glendale. Dr. Puzantian also serves as Deputy Editor for the Carlat Psychiatry, Child Psychiatry, and Addiction Treatment Reports and is co-author of Medication Fact Book for Psychiatric Practice.

# Nazia Rashid, PharmD, MS

Dr. Rashid, who joined KGI in April 2016, is a clinical and research pharmacist with a health economics and outcomes research (HEOR) degree from USC. She worked at KPSC Managed Care Markets and Drug Information Department where she led and conducting various HEOR projects for 12+ years, including retrospective database analyses, prospective/registries, clinical intervention, translational research, formulary evaluations, value propositions, cost-effectiveness analyses, and patient reported outcomes. She has experience in creating many interactive tools for physicians and healthcare decision makers to utilize and to improve data gathering, collection and evaluation. Dr. Rashid has created many database registries and performs strategic planning related to the involvement of informatics and database analysis. She loves teaching and has been a preceptor for many pharmacy residents for 10+ years.

Gregory Reardon's career experience has ranged from pharmacy practice to academia to healthcare entrepreneurship.
